### OUR ENTRANCE INTO GOD'S FUTURE: 2021

As we prepare to enter into a new calendar year with anticipation and hope, particularly after a difficult and challenging year past, may we be able to see and experience God's presence and purpose throughout the world. Even as COVID-19 continues to make itself present in devastating ways, may we continue to walk in faith as we direct our attention and prayers to God and God's ways of grace and mercy, healing and love in and through Christ Jesus. For in Christ, we have come to believe that God is with us, directing the world in which we inhabit in the path of righteousness and the fullness of life towards eternal peace. To recognize such, begins with a new way of looking, a way of "seeing" that casts off the doubts and indifferences that emerge from the troublesome aspects experienced in life, that move in a direction apart from hope. This "new" way of seeing begins with a directional turn towards God's promises and presence, in short, repentance.

As did John the Baptist, Jesus began his public ministry by saying, "Repent, for the kingdom of heaven has come near" (or "is at hand"). To live within God's glorious and eternal reign is to respond to this gift in the here-and-now with complete trust (faith) and adaptability. The call to repent is a realization that a commitment to change is necessary. Awareness of the presence of the kingdom of heaven seems highly unlikely for those who would be or are unwilling or unable to make changes in their world-view, lifestyle and commitment to God's possibilities and promises.

The call to repent is a challenge to be moved, by the power of God's Spirit, away from those idolatries that attempt to convince us that we are going in the "right" direction and to be placed firmly in the hands of a God who chooses for us, in the life of Jesus, salvation and life eternal that can be seen as a present

reality. In other words, Jesus seems to be saying, "See, the kingdom of heaven is not something you have to wait around for, nor is it something to be gained only later by acquiring a special skill set or by attaining a level of religious perfection. It's here for the taking. With eyes of faith, allow yourselves to be moved by God's grace to see and receive the gift, and believe. Go ahead, and enter now."

On several occasions in Matthew's Gospel, Jesus speaks against those understandings or actions that may and can prove as hindrances for entrance into the kingdom of heaven. Near the beginning of Jesus' Sermon on the Mount, he indicates that "unless your righteousness exceeds that of the scribes and Pharisees, you will never enter the kingdom of heaven" (MT 5:20). How are we to perceive this condition, as warning or new possibility in Christ? Does it suggest that the kingdom of heaven demands high standards for entrance, possibly indicating that a particular set of values and actions are more worthy than others, and are rewarded as such? Or is Jesus' statement intended to provoke his followers into an understanding of righteousness and the kingdom of heaven that is distinctive from that ascribed by the scribes and Pharisees, which could be suggestive of a system that rewards "certain" works that elevate the doer into an arena of divine favor and dismisses those who "fail" at such works? Is not this "higher righteousness" to be seen and experienced through the eyes of grace?

Later in Matthew's Gospel, Jesus again speaks to that which may hinder or possibly prevent entrance into the kingdom of heaven, as he responds to the sadly ridiculous question of "Who is the greatest in the kingdom of heaven" (MT 18:1). (Seems like those who seek righteousness by their works are always looking for an angle that will lift them to a higher level than others.) Jesus has this to say: "Amen, I tell you, unless you change and become like children, you will (con't page 2)

*Pastor...con't from pg. 1* never enter the kingdom of heaven.” (Notice: change and repentance are of the same suit.)

Added to this, Jesus speaks favorably to the humility evidenced by child-like awareness, receptivity and trust. Is the change that Jesus calls for an active shift of strategy and implementation that focuses upon what might work to gain access to the kingdom, or is Jesus calling us away from those learned behaviors that seek to manipulate power, influence and control as regards to our fate or destiny? Entrance into the kingdom of heaven as Jesus “sees” it may have less to do with human striving than with a child’s view of being cared for absolutely and completely.

Still later in Matthew’s Gospel, Jesus again is confronted by a rich person who seeks a way to “get” eternal life- “What good deed must I do?” (MT 19:16). The absurdity of like questions lingers even as Jesus points us away from an absolute trust in our own “good works” to gain access to God’s favor. “Good works” are to flow from the reception of God’s favor (grace) but are not the means to “get” God’s favor. And so Jesus warns, “Amen, I tell you, it will be hard for a rich person to enter the kingdom of heaven. Again I tell you, it is easier for a camel to go through the eye of a needle than for someone who is rich to enter the kingdom of God” (MT 19:23-24). Wealth may get us things by worldly standards, but it may serve as a hindrance in becoming able to see and experience the favor God lays before us as gift in and through Christ.

Entrance into the kingdom of heaven, by Jesus’ counsel, may seem difficult if not impossible, but only if and as we maintain an adherence to our own motivations, desires, and actions as the means necessary for such entrance. We fail, not by a lack of effort or production, but simply by not trusting in the possibility of God who provides for us a kingdom, a future as a gracious gift of love. Believe, that you may see! May we truly be able to see this new year from the perspective of God’s promised presence.
